## TUITION CONTRACT 2010-2011

The undersigned parent or guardian agrees to pay the Torah High Schools of San Diego the following for school year 2010-2011:

\$17,000	Tuition (\$18,500 if registered after 1/15/10)
\$750	Registration (Includes Book Fee and Lab Fee)

The following are payment plans for tuition. The registration, book, and lab fees are due by January 15<sup>th</sup>, 2010, and are not included in the following amounts. **Please note that there is a substantial difference in tuition charges for those who have not registered by January 15<sup>th</sup>, 2010.** If you have already made a partial payment, please deduct this amount from the overall total. The first tuition payment is due on July 1<sup>st</sup>, 2010, with ten equal payments concluding on April 1<sup>st</sup>, 2011. Please choose one of the following plans. **Please note that there is a 3% surcharge for those paying with a credit card.**

For those registering **by** January 15th, 2010:

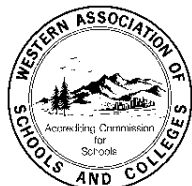
For those registering **after** January 15th, 2010:
